And whereas the trustees have, at the request of the settler, agreed to act as the first trustees of these presents as testified their being parties to and executing these presents.

And whereas it is necessary to declare the aims and objects of the public charitable public trust, being constituted under these presents.

**NOW THIS INDENTURE WITNESSES AS FOLLOWS: -**

1. That, in order to effectuate his aforesaid desire, the settler has set apart and handed over to the trustees, a sum of Rs. 51,000 (Rupees Fifty One Thousand Only) (hereinafter called the "Trust Fund" which expression shall include cash and any other property of investments of any kind whatsoever into which the same of any part thereof might be converted, invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

That the name of the trust shall be **BIHAR VIKAS EDUCATIONAL TRUST** and Registered office will be situated At.- **Adhiwakta Nagar, Ward No.- 14, Po.+Distt.- Gopalganj, Pin.- 841428 (Bihar)** it can be changed at such other place as the board of Trustees may decide from time to time.

**Administrative/ Branches or Project Offices :** Trust may have administrative/ or branches or project offices in such place or places as decided by the Board of Trustees time to time within the operational area of the Trust under the over all guidance and control of the registered office.

**Area of Operation :** The operational area of the trust shall be whole India and may be reduced as Trustees may decide.

**Fund of the Trust :** The assets, together with all further donations, contributions, grant and loan in any shape or form made to the said Trust from time to time, and rents, profits and income thereof and the stocks, funds and properties representing the same shall be held by the Trustees upon Trust for the objects and purposes and subject to powers and provisions hereinafter set out.

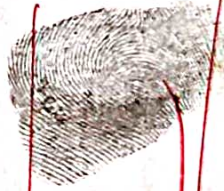
2. That the objects for which this trust is established are :-
- 2.1 To set motion and play a proactive role in giving direction for a quiet social movement/revolution for socio-economic Development, educational, cultural, scientific, technical, financial, ethical prosperity and take spearheaded initiative to spread the gain or prosperity in the benefit of throughout masses of world of living creature.
  - 2.2 To organize, promote, undertake, sponsor, carryout, all programmes for the benefit of naturally challenged person, schedule caste, schedule tribes, people under poverty line, old-aged, widow, and down trodden irrespective of caste, creed, sex and religions.
  - 2.3 To establish develop, maintain schools, colleges, libraries, universities, laboratories, skill developments centers, competition, preparation centers, yoga and spiritual centers, sports training centers, vocational training centers, research and other institutions for the development and advancement of education and diffusion of knowledge among the public in general.
  - 2.4 To establish, maintain and run studentship, scholarship and award programme and render other kind of aid to students including supply of study materials, books, stipend, medals and other incentives.
  - 2.5 To Organize programme for the promotions of pre-primary education, non-formal education, computer & information technologies, leadership development, technologies, leadership development, techno-entrepreneurship development educational, infrastructure research and development, socio-scientific research, management.
  - 2.6 To undertake, establish, assist, organize or conduct the programme of research, management and infrastructure development in the field of health & family welfare.
  - 2.7 To establish, organize, run or maintain hospital, Nursing Institute, Para Medical Institute, Medical College, Medical Education and research center in state-of-art.

- 2.11 To conduct and undertake the research of technologies advancement, productivity enhancement, cost effectiveness technologies and methodologies in the field of agriculture, allied industries, cottage industries, veterinary and co-operatives.

- 2.17 To make the market-mechanism and even indulge in marketing activities for giving most favorable and optimum value to the farmers. To develop the infrastructure for the easy and safe delivery of agro-products. Also establish and run financial institution for the benefit of agriculture and allied industries-related people.
- 2.18 To undertake all programmes for ensuring social accountability in conservation, preservation and control to the environment, forest, wild life.
- 2.19 To undertake awakening and intervention programmes for enforcement of environmental law, Access to environmental information, town and country planning, integrated pollution

- 2.45 To accept loan, Grant-in-aid, donation (Either in cash or kind), Subsidy or other assistance lawfully, either from National and/ or International agencies for the attainment of the objective of the trust.
- 2.46 To undertake, organize, investigate, participate, sponsor, the human right programmes including awakening of human rights, preservation of fundamental rights, protection & safeguards to the victims of human rights violations, for the freedom, dignity and peace of the people. Also, undertake study, research, publications, treaties with national and international institutions and award programmes, for the effective implementation of Human Rights.
- 3. All the activities shall be Non Profitable and shall be done on 'No Profit-No Loss' basis.
- 4. All the incomes, earnings, movable/immovable properties of the trust shall be solely utilized and applied towards the promotion of its Aims and Objects only as set forth in the deed of its Aims and objects only as set forth in the deed of the trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in

any manner whatsoever to the present or the past members. No members of the trust shall have any personal claim on any movable or immovable properties of the trust or make any profits, whatsoever, by virtue of his membership.

5. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contribution from time to time.
6. That the Trust Fund shall not be applied for any purpose other than those specified in Para 3 herein above unless the other objects added to the trust objectives.
7. That the Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the trust.
8. Subject to the Provisions of Income Tax Act, 1961 as amended from time, the Trustees will keep the Trust Fund or such portion thereof, as they may, in their absolute discretion, think fit and proper, without being answerable or accountable to the beneficiaries or any other party for any loss invested in such shares, stock, securities and debentures of acquisition or mortgage by way of fresh charge on any immovable property in India, of free-hold or lease-hold tenure, and may deposit the amounts with any scheduled Bank, company or private firm or Individual on such terms and conditions as they think fit, In the matter of investment of Trust funds, the provisions of section 20 of the Indian Trust Act shall apply; in the event of Trustees purchasing any immovable property or properties or advancing moneys or mortgage, they shall be entitled to accept such title or evidence of title as they shall think fit in their absolute and uncontrolled discretion. The Trustees shall have power, if any deed in their absolute discretion to sell the Trust Fund or any part thereof and any such immovable property purchased by them under the power aforesaid and any other shares, securities, etc. and stand possessed of the money to arise from such sale upon after paying there out the expenses pertaining to such sale upon there out the expenses pertaining to such sale upon the Trusts and with the subject to powers and under these presents declared and contained concerning the Trust Fund which or the proceeds thereof, shall have laid out in purchase of property or properties as have laid out in purchase of property or properties as aforesaid or such of them as shall be then subsisting and capable of taking effect.

9. **ADVISORY BOARD :**

The Board of Trustee is authorized to appoint or nominate any time, the Advisory Board for guidance or to solve any matter/issue. Board of Trustee of the Trust can nominate any trustee/Office- Bearer as the Settler-Cum-Chairman of this kind of advisory Board. Member of Advisory Board have no power to vote in any Board of Trustee meetings of the Trust. Advisory Board Members are also not eligible for nomination as Trustee. The recommendations made by Advisory Board in any matter are only suggestive nature and binding on Board of Trustee to accept it.

10. **POWERS AND FUNCTIONS OF THE BOARD OF TRUSTEES :**  
For the furtherance of the objects of the trust, the trustees shall have the following powers:

- 10.1 To accept any donation, contribution grant loan or subscription in cash or kind, from any person (s) body of persons or Trust, Govt./ semi-Govt. department or agency, financial institution, bank, national or international donor with or without conditions.
- 10.2 To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- 10.3 To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- 10.4 To open account in the name of the Trust, with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- 10.5 To adjust, settle, compromise, compound refers to arbitration, all actions, Suits claims, demands and proceedings regarding the Trust Fund.
- 10.6 To Engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator of Settler-cum-Chairman or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.
- 10.7 To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any

with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within these objects of the Trust and to put to any proper condition upon which such grants and other payments including taking land on lease may be made.

10.16 To take over or amalgamate with any other Charitable-Public Trust, Trust, association, or institution with similar-objects.

10.17 To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.

10.18 To take land/property on lease and then after sublease the land/property to the farmers and other organizations like co-operative/society/urban public bodies/gram panchayat or any being thereof in rural area/local municipal/district and other bodies corporation/company for farming/agriculture/plantation purposes.

10.19 To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.

11. The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.

12. The Trustees will not be entitled to receive any remuneration, but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

13. The Settler-cum-Chairman for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period of on such terms as to retirement and reappointment as the trustees for the time being consider proper.

14. **A PERSON SHALL CEASE TO BE A TRUSTEE EITHER:**

14.1 If he/she without leave of absence does not attend three consecutive meeting of the Trustees or for one calendar year, whichever is longer, or for one calendar year, whichever is longer, or

- 14.3 In the absence of Settler-Cum-Chairman, Secretary & Treasurer will take charge and function of Settler-Cum-Chairman.
15. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.  
The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:
- 15.1 Five Trustees shall form a quorum for a meeting of the Trustees.
- 15.2 All matters will be decided mutually by the Trustee.
- 15.3 Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
- 15.4 Settler-Cum-Chairman, Secretary & Treasurer have management of the affairs of the trust and the over all supervision and superintendence of the trust and all institutions/units run by the trust and all matters incidental thereto.
16. The Trustees shall have the power to determine in case of doubt whether any money of property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.
17. **MAINTENANCE OF BOOKS OF ACCOUNTS:-**  
Regular books of accounts of the Trust shall be maintained incorporating all the revenue and expenditure and such books shall be closed once every 31st March.
18. The Trust and the Trust funds shall be Irrevocable for all the times.

- 19. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose, which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.
- 20. The accounts of the Trust shall be audited every year by a Chartered Accountant or a firm of Chartered Accountants, that will be appointed by the Board of Trustees with the consultation of the Settler-Cum-Chairman.
- 21. The audited accounts of the Trust shall be adopted a meeting of the Board of Trustees called for the purpose, and remuneration of Chartered Accountant or Firm of Chartered Accountants shall be fixed by the Board of Trustees.

**22. POWER & FUNCTION OF THE OFFICE BEARER**  
**SETTLER-CUM-CHAIRMAN:**

- 22.1.1 The Settler-Cum-Chairman shall preside at all meetings of the trust, when he/she is present and shall exercise such other powers as are conferred upon her by these rules. The Settler-Cum-Chairman may call for an emergency meeting through Settler-Cum-Chairman Signed notice in a shorter period. The decision of Settler-Cum-Chairman that a resolution has been carried or cost shall be conclusive, unless such a decision is challenged and a poll is demanded; on poll being demanded, the same shall be taken in such manner, as the Settler-Cum-Chairman shall have a second or casting vote.
- 22.1.2 The Settler-Cum-Chairman shall be the principal executive officer of the Trust and shall preside over the meeting of the Trust.
- 22.1.3 The duty of the Settler-Cum-Chairman shall be to ensure that the rules of the Trust and resolution of all the meeting are carried out and followed.
- 22.1.4 The Settler-Cum-Chairman shall call meeting of the Trust through the Managing Trustee as per rules and regulation.
- 22.1.5 The Settler-Cum-Chairman shall be the main executive officer of the Trust and shall conduct all official correspondences under his/her signature and he/she shall have supervision/administrative & financial powers over all the Institutions of the Trust and shall have power of visiting and

- controlling the institutions as and when necessary for discharging his/her duties.
- 22.1.6 Settler-Cum-Chairman shall prepare all the agendas of meetings himself/herself if and/or with the consultation of the Managing Trustee or Trustee if required or desirable.
- 22.1.7 Settler-Cum-Chairman shall convey all meetings of the Trust as per scheduled and give intimations here of to the members in time.
- 22.1.8 All contracts shall be entered into his name on behalf of the Trust.
- 22.1.9 The Settler-Cum-Chairman should get the accounts audited according to the rules.
- 22.1.10 To operate Bank account if authorized by Board of Trustee.
- 22.1.11 He/she shall have power to keep in hand Rs. 5,000- (Rs. Five Thousand) as deemed necessary to meet immediate/contingent or urgent expenditure to be incurred in day to day business of the Trust.
- 22.1.12 He/she shall be able to seize all powers to the and establishments of the Trust, and vest in him/her suspending the unit's management in unavoidable emergent and desirable circumstance, in the interest of the concerned establishment, institution to maintain to every purpose of the Trust and shall form an ad-hoc committee to run to business of the establishment/ institution till the position improves. It shall be incumbent on the part of the Settler-Cum-Chairman to have the settler in good confidence and obtain approval in the Board of Trustee.
- 22.1.13 The Settler-Cum-Chairman shall see that the every collected amount is deposited in Bank in time as per rule.
- 22.1.14 The Settler-Cum-Chairman will submit in the meeting the report of the working of the Trust and all its units along with detailed statements of receipts, expenditure of existing resources of fund or money and bank balance of the Trust and institutions if required.
- 22.1.15 He/she can authorize work, rights, functions and duties to any of the Trustees in writing and entrust to perform independent ally with the liabilities and also seize anytime

**22.2 SECRETARY:**

- 22.2.1 He/She shall produce the accounts of the trustee before Settler-Cum-Chairman for approval.
- 22.2.2 He/She shall appoint, suspend, discharge, fix the salary, make payment of the employees of the institution and conducted by the institution and conducted by the trustee on behalf of the Settler-Cum-Chairman.
- 22.2.3 He/She will produce the expenditure of the trustee before the Settler-Cum-Chairman for approval.
- 22.2.4 In the absence of Settler-cum-Chairman, Secretary will take charge and function of Settler-cum-Chairman.

**22.3 TREASURER:**

- 22.3.1 The Treasurer will act under the direction of the committee.
- 22.3.2 Any amount exceeding Rs. 5000/- which is not required for immediate use shall be paid into such bank or banks as may be approved or by the committee. The Treasurer shall ordinarily receive all payments and disburse the amount passed by the Settler-Cum-Chairman and shall maintain proper books of accounts.
- 22.3.3 He/She shall maintain the account in proper and prescribed form. He/She shall deposit and withdraw the amount of the trustee in the bank or in the post office with the joint signatures of any two of the Shelter-cum-Chairman, Secretary and Treasurer will operate the bank accounts.
- 22.3.4 In the absence of Secretary, Treasurer will take charge and function of Secretary.

**22. ALLOWANCE TO TRUSTEES & OFFICE-BEARERS**

If at any time any Trustee acts as a whole time office-bearer of the Trust or renders any special service, the Board of Trustees may in its discretion pay such remuneration or allowances to such Trustees as it may think proper.

23. **BANK OPERATION:**

24.1 The bank accounts will be opened by the name of the Trust for its registered/administrative/branches, Project offices, centers or institutions run or conducted by the Trust with a Nationalized or scheduled bank or other bank appoint or permitted by Reserve Bank of India or in Post Office and shall be operated by joint signature.

24.2 The joint signatures of any two of the Shelter-cum-Chairman, Secretary and Treasurer will operate the bank accounts.

**AMENDMENTS :**

This Trust, Trust-fund, trust objective and the provisions relating to the appointment of the Settler constituting the Board are irrevocable. Subject as aforesaid, the terms of this deed may be amended, altered or modified by a majority of 2/3rd members of the Board present and voting in a meeting called for the purpose.

Provided, however, that no amendment contrary to the objects of the Trust herein before set forth shall be valid and effective.

24. **DISSOLUTION OF TRUST:**

In case of the dissolution of the Trust the remaining assets after satisfaction of all its debts and liabilities shall be handed over to any public charitable Trust or Society having, similar or partially similar objectives, which has been registered under section 12A of the Income Tax Act. or by the direction of settler (which expression shall deemed to include his/her survivors, heirs, Executors, successors, legal representatives and assignees) and shall provide a competent managements and bodies for its sponsored institutions to promote aims and objects of the " Trust Dissolved". In case of any dispute the Trust will be dissolved after taking permission of competent courts.

25. **JURISDICTION OF COURT:**

The competent court in Gopalganj (Bihar) shall have exclusive jurisdiction to decide any question regarding the interpretation and constriction of this Deed or administration
